

BIO OF PROFESSOR DR. MOHAMMAD KABIR HASSAN



Professor Dr. M Kabir Hassan is Professor of Finance in the Department of Economics and Finance at the University of New Orleans. He currently holds four endowed Chairs- Hancock Whitney Chair Professor of Economics I, Hancock Whitney Chair Professor of Economics II, Hibernia Professor of Economics and Finance, and Bank One Professor in Business- in the University of New Orleans. *Professor Hassan is the Winner of the 2016 Islamic Development Bank (IsDB) Prize in Islamic Banking and Finance.* Professor Hassan received his BA in Economics and Mathematics from Gustavus Adolphus College, Minnesota, USA, and M.A. in Economics and Ph.D. in Finance from the University of Nebraska-Lincoln, USA respectively. Dr. Hassan stood first in combined merit list in the Secondary School Certificate (SSC, equivalent to O level) in 1978 from Comilla Zilla School, Comilla, Bangladesh in 1978 and Higher Secondary Certificate (HSC, equivalent to A level) in 1980 from Comilla Victoria Government College, Comilla, Bangladesh in 1980, respectively. Professor Hassan has been selected as a Senior Fulbright Scholar for 2022-2023.

Professor Hassan is a financial economist with consulting, research and teaching experiences in development finance, money and capital markets, Islamic finance, corporate finance, investments, monetary economics, macroeconomics, Islamic banking and finance, and international trade and finance. Professor Hassan has done consulting work for the World Bank, International Monetary Fund, African Development Bank, Transparency International-Bangladesh (TIB), Islamic Development Bank, United Nations Development Program (UNDP), the Bangladesh Bank, the Saudi Arabian Monetary Authority (SAMA), Government of Turkey and many private organizations. Professor Hassan has been elected a Board Member of Ethics and Governance Committee and Education Board of the Accounting and Auditing Organization for the Islamic Financial Institutions (AAOIFI). Professor Hassan served as the Distinguished Visiting Professor at the National University of Malaysia (UKM) and has recently been appointed as Distinguished Visiting Professor at the UiTM, Malaysia. Dr. Hassan is elected to the Advisory Council of the World Zakat Forum (WZF), 2021-2023. Professor has served as Member of the Oxford University Said Business School faith-based investing initiative during 2021-22. He is also a member of Christin Michelson Institute (CMI) in 2021.

Dr. Hassan served as Associate Chair from 2001-2004. He is currently serving as Graduate Program Coordinator of Ph.D. in Financial Economics. Professor Kabir holds numerous on-campus academic service positions. He was in the Committee on Academic Computing (University): 1998-2001, and Graduate Program Committee (College): 1998-2004, 2007-2020. Professor Hassan is a member of Instructional Resources and Responsibilities Group. (College), Teaching Effectiveness Committee (Department), Graduate Program Committee. (Department), and Departmental Seminar Committee (Department). He served as the Faculty Advisor for Financial Management Association Honor Society of UNO student chapter (Department). He served on the Internal Review of Ph.D. Program in Financial Economics (Department) and Departmental Search Committee in Finance: 1994-1995; 1995-1996 (Department). Professor Hassan is the Chair of Finance Ph.D. Comprehensive Examination Committee, Monetary Theory and Institutions, and Exam Committee Member of MS in Finance, and member of MBA Program Committee (College): 1996-2000; 2008-2020 as well as member of Graduate Council: 2015-2022.

Dr. Hassan provided academic leaderships to several organizations such as President of Southwest Finance Association (SWFA), Southwestern Society of Economist (SSE), Academy of International Business-US Southwest and Academy of Economic and Development Studies on Bangladesh (AEDSB). He was member of Board of Directors, Academy of Financial Services: 1996-1999. He also served as the board member of Southern Finance Association (SFA).

Professor Hassan has over 555 papers [397 SCOPUS, 286 SSCI, 142 ESCI, 354 ABDC, 230 ABS] published as book chapters and in top refereed academic journals. The number of publications would put Professor Hassan in the top 1% of peers who continue to publish one refereed article per year over a long period of time according to an article published in *Journal of Finance*. Professor Hassan has also been

cited as one of the most prolific authors in finance literature in the last fifty years in a paper published in Journal of Finance Literature. His publication record puts him among the top 5.6% of all authors who published in the 26 leading finance journals. He is among the top 5% of authors according to the number of Journal Pages at RePAC/IDEAS. Professor Hassan is among the top three presenters in the Financial Management Annual Meetings during 1990-2022. According to a 2021 Stanford University survey of well-cited authors worldwide, Professor Hassan is cited as one of the world's top 2% of authors. Professor Hassan has an H-index of 81 from Google Scholar. Professor Hassan's research interest score exceeds 99% of the ResearchGate members. Dr. Hassan is ranked #420 in the world ranking and #292 in United States according to D-index (Discipline H-index) metric, which only includes papers and citation values for an examined discipline. The ranking includes only leading scientists with D-index of at least 30 for academic publications made in the area of Economics and Finance (<http://research.com/scientists-rankings/economics-and-finance>)

A frequent traveler, Dr. Hassan gives lectures and workshops in the US and abroad and has presented over 509 research papers at professional conferences and has delivered 334 invited papers/seminars. **For his outstanding research and scholarly work, Dr. Hassan has been recognized with a Lifetime Achievement Award by UNO Research Council in 2019.** Professor Hassan visited many international universities as Distinguished Visiting Professor. He has won 39 Best Paper Awards from Academic Conference presentations. Professor Hassan has been honored by the fellow members of Academy of Economics and Finance for life-long contribution to teaching, research, and service in 2016, 2018 and 2022 respectively.

Professor Hassan has supervised 67 doctoral theses at the University of New Orleans and acted as External examiners for 53 dissertations from countries like Australia, New Zealand, USA, India, Bangladesh, Malaysia, Pakistan, Italy, France, and Canada. Many of his students are now well placed in the academia (Department Chairs, Deans and Professors), government (Secretary, Under-Secretary, and Central Bank Deputy Governor) and private sectors (CEO and CFO). Professor Hassan evaluated promotion documents of many faculty members from the USA and abroad.

Professor Hassan has numerous teaching awards for his outstanding teaching from the University of New Orleans and outside academic organizations. His teaching awards include Jamaica Executive MBA, JEMBA (2002, 2003, 2009), US EMBA (1999, 2000, 2003, 2007, 2015), Executive master's in health care management EMHCM (2002, 2003, 2015), Thompson-Reuters Outstanding Educator (2002, 2004, 2006), UNO College of Business Administration Professor of the Year (2001), UNO Favored Professor (1998), University of Nebraska-Lincoln Graduate Assistant Award (1990). Professor Hassan won 27 Teaching Awards from UNO and external academic and professional organizations. He has also received 2017 Islamic Banking and Finance Excellence Award, COMSATS, Lahore, Pakistan, **2018 University of New Orleans Gordon H. "Nick" Mueller International Leadership Medallion, 2019, 2019 University of Louisiana System Outstanding Faculty Member Award and 2019 and 2022 UNO Library Book Prize Award.**

He co-authored the book *A Guide to Islamic Asset Management: Portfolio Investing with Sharia*, with John Sandwick, and Pablo Collazzo, published by Edward Elgar, USA, 2020. He co-authored with Ahcene Lahsasna and Rubi Ahmad *Forward Lease Sukuk in Islamic Capital Market: Structure and Governing Rules* published by Palgrave-Springer, New York in 2019. He co-authored with Md. Zohurul Islam, *Zakat Administration: The Principles and Contemporary Practices*, Bangladesh Institute of Islamic Thought (BIIT), Dhaka, Bangladesh, August 2022. Professor Hassan co-authored with Shafinar Ismail and Suhani Rahmat,” “Endowment and Islamic Social finance: Waqf and SMEs,” Edward Elgar Publishing, 2022. Professor Hassan with Aishath Muneeza wrote “COVID-19 and Islamic Finance,” Cambridge University Press, UK, 2022. Professor Hassan with Magda Ismail Abdel Mohsin and Aishath Muneeza is co-authoring “Application of Zakat: From Classical and Contemporary Perspective,” to be published World Scientific Press, June 2023.

Professor Hassan has written the first textbook (co-authored with Dr Kayed and Dr. Oseni) on *Islamic Finance* that was published by Pearson in 2013. His second textbook *An Introduction to Islamic Finance*” co-authored with Salman Sheikh and Selim Kayhan was published in 2020 by the World Scientific Press. Hassan wrote an Islamic Financial Management Supplement McGraw-Hill Education, UK: Supplement to Fundamentals of Corporate Finance, 13th Edition, ©2022 | Ross, Westerfield, Jordan | McGraw-Hill Higher Education — USA. Professor Hassan also co-edited a widely used textbook on Islamic banking in Bangladesh.

Professor Hassan is the co-editor (with Mervyn K. Lewis) of *Handbook of Islamic Banking*, by Edward Elgar, 2007, *Handbook on Islam and Economic Life* (Edward Elgar, 2014), and co-editor (with Michael Mahlknecht) *Islamic Capital Market: Products and Strategies* (John Wiley and Sons, 2011). His co-edited book on *Islamic Corporate Finance*, with Mamunur Rashid and Sirajo Aliyu was published by Routledge (Taylor and Francis Group) in 2018. Two volumes on *Revitalization of Waqf for Socio-Economic Development* with Khalifa Mohamed Ali and Abd elrahman Elzahi Saaid Ali were published by Springer Nature Switzerland AG in 2019. Professor Hassan co-edited *Emerging Issues in Islamic Finance and Law and Practice in Malaysia* with Umar A. Oseni and Rusni Hassan that was published by Emerald in 2019.

Professor Hassan book *Handbook of Empirical Research on Islam and Economic Life* was published in December 2016 by Edward Elgar Publishing Company. Professor Hassan ’s edited volume with Professor Mehmet Sarac on *Islamic Perspectives on Sustainable Financial Development* is published by Istanbul

University Press in 2020 and *Sustainable Development Goals and Islamic Finance* with Mehmet Saraç and Ashraf Khan) published by Palgrave-McMillan in 2021. His co-edited book with Aishath Muneeza and Adel Sarea *COVID19 and Islamic Social Finance* is published by Routledge in 2021. He also co-edited a second book *Impact of COVID-19 and Islamic Social Finance* with Aishath Muneeza and Adel Sarea) published by Routledge in 2020. *Islamic Finance in Africa*, co-edited by Kabir with Aishath Muneeza and Karamo Sonko is scheduled to be published by Edward Elgar in 2022. Professor is the Co-Editor with Paolo Biancone and Aishath Muneeza of *Islamic Finance in Eurasia: The Need for Strategic Change*, to be published by Edward Elgar Publishing, June 2023

Currently he is advisor to Muslim Student Association (MSA) at UNO.

Professor Hassan is married with two children. His wife, Dr. Tahmina Hassan, a board-certified internist and geriatrician, is the chief of CLC at Veterans Memorial Hospital in New Orleans, Louisiana, USA. Their daughter, Aniqqa Hassan, earned her BA and MS from Harvard University (Neurobiology and Global Health-2016 and 2020 respectively) and works at a fintech start-up in Seattle, Washington. Their son, Arman Hassan, earned his BA in Economics and Computer Science from Harvard University in 2018, is now an MBA student at the Wharton School of the University of Pennsylvania. He was a Senior Analyst at the Audax Asset Management company in Boston, Massachusetts. Arman’s wife Sera Chowdhury is the Vice-President of Sales at MineralTree, Inc.

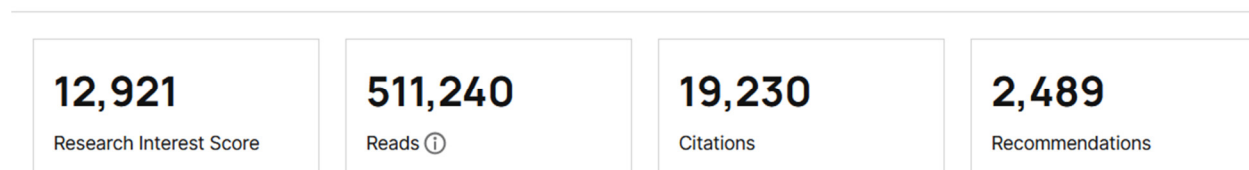

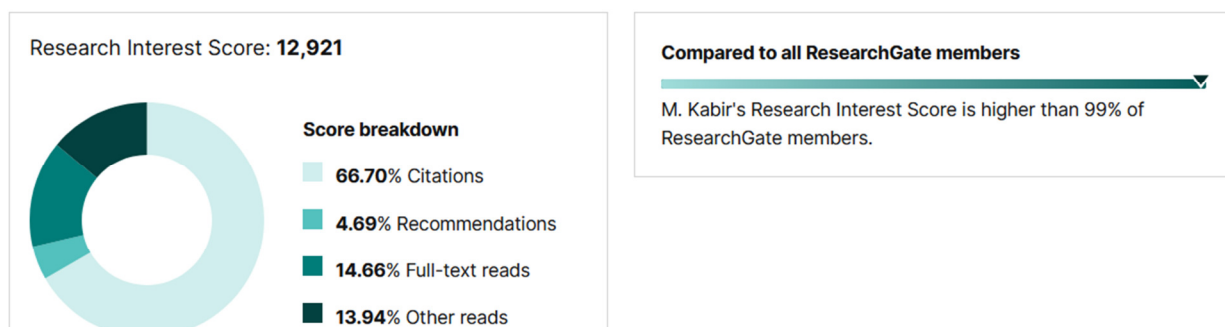

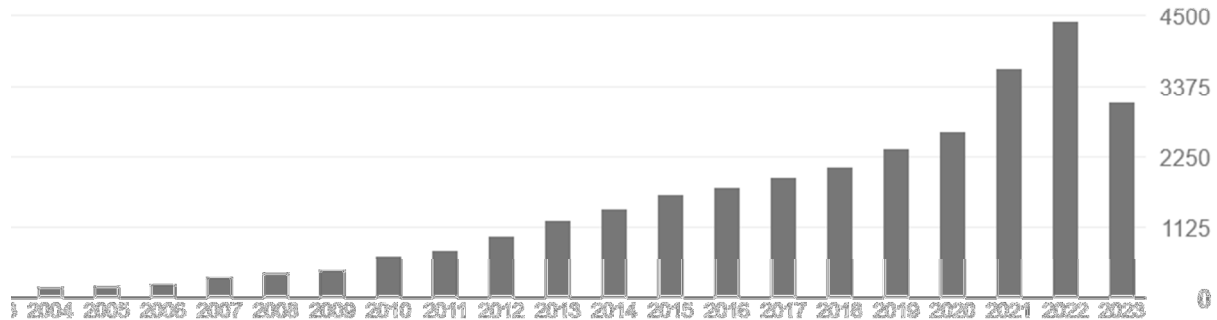
